What is MPS-ABC?

- guaranteed record-keeping system for: crop protection agents, energy, fertilisers, water and waste
- measuring and management tool to aid transparency in operations
- · marketing tool: demonstrably sustainable
- FSI2025 is currently developing additional requirements in the field of 'Good Environmental Practices'.
 MPS-ABC growers already comply with these requirements (by means of Credible Record-keeping)

What are the requirements for MPS-ABC?

- 1. Register and request a quotation
- 2. Start-up interview with MPS staff member (to explain how the system works)
- 3. One year online record-keeping via MY-MPS (including usage overview & cultivation plan)
- 4. Initial audit
- 5. MPS-ABC certification
- 6. Periodically thereafter: independent inspections, audits and sampling, and continuing record-keeping



The demonstrable absence of certain active substances in and on products in the flowers & ornamentals industry

What is MPS-ProductProof?

- MPS-ProductProof demonstrates that individual products do not contain certain active substances and that these were not used during the growing process
- · ProductProof is an @-on (add-on) to MPS-ABC

Advantages of MPS-ProductProof

- boosts your corporate image and helps distinguish it from other growers
- responds to society's demand for sustainable, safe products
- makes your business visible to traders and retailers in the MPS Trade Portal

What are the requirements for MPS-ProductProof?

- 1. Register and request a quotation
- 2. A valid MPS-ABC qualification
- 3. Minimum of two independent samples (within three months)
- 4. Inspection of crop protection agents for authorisation (at product level)
- 5. MPS-ProductProof Status
- 6. Then a minimum of four samples per year



Certificate to demonstrate Good Agricultural Practices, benchmarked with GLOBALG.A.P.

What is MPS-GAP?

- access certificate required to supply products to international retailers
- addresses requirements in the field of, among other things, traceability, hygiene, environment, crop protection agents and recall procedures
- · in line with global standard GLOBALG.A.P.
- in line with FSI2025 requirements

- makes your business visible to traders and retailers in the MPS Trade Portal
- · boosts your corporate image in the floriculture sector
- · complies with international retail requirements

What is required for obtaining MPS-GAP and/or MPS-SQ certification?

To obtain MPS-GAP and/or MPS-SQ certification, you must first be an MPS-ABC participant, and ultimately hold a valid MPS-ABC qualification.

- 1. Obtain information regarding the certificate you wish to acquire Contact the MPS Service & Support team and visit www.my-mps.com
- 2. Arrange a possible company visit or telephone call to receive an explanation of the certificate by an MPS staff member
- 3. Request a quotation
 - You can ask for a quotation request form during a company visit or via www.my-mps.com
- 4. Implementation of the certificate requirements
- 5. Internal audit
 - If you need help with this, we can refer you to an external consultancy
- 6. Certification audit
